The meeting of the Board of County Commissioners for Cecil County, March 20, 2012 was called to order by Commissioner Mullin at 7:02 p.m. and opened with the Pledge of Allegiance.

Commissioner Moore made a motion to approve the minutes as amended, seconded by Commissioner Hodge and unanimously carried to approve.

- INFORMATIONAL ITEMS -
- COMMISSIONER COMMENTS-

Commissioner Hodge welcomed everyone for coming out. Commissioner Hodge advised the public FEMA has reimbursed the County over \$111,000 in efforts resulting from storms Irene and Lee. Commissioner Hodge updated the public on the Legislative Session and his concerns with the Senate Bill 236 a septic bill and Senate Bill 602 regarding mandating fire sprinklers in all new homes. Commissioner Hodge encouraged citizens opposed to these issues to get involved. Commissioner Hodge advised the Environmental Protection Agency is moving forward regarding Regulatory Guidance relating to Waters of the U.S.

Commissioner Dunn welcomed everyone and recognized John Denver for being selected to serve as President to the State Firemen's Association. This is only the second time someone from Cecil County has been selected to serve as President of the organization.

Commissioner Broomell informed the public the Volunteer Fire Companies have been working on ways to improve their response times and plan to address the Board with their plan. Commissioner Broomell advised the public the Citizens Budget Advisory Committee has completed a draft list of recommendations. Commissioner Broomell commented she is impressed with the draft list and she hopes to share the recommendations with the public soon.

Commissioner Moore congratulated Erica Jesonis, of the Cecil County Public Library for being recognized by the Library Journal Magazine which is a national publication as a "Mover and a Shaker". Commissioner Moore announced Early Voting will begin Saturday, March 24 through Thursday March 29.

Commissioner Mullin recognized the Ewing Family for being named Cecil County Farm Operation of the year.

William Feehley, Cecil County Treasurer, presented the Treasurer's report as of, February 29, 2012 to the Board.

Commissioner Hodge asked Treasurer Feehley if there were any trends that concerned him.

Treasurer Feehley commented there were no trends that alarmed him. He did comment he would like to see interest rates would go up.
