Registration is now being accepted for Sports and Arts, an after-school enrichment program being offered in various school locations brought to you by the Cecil County Parks and Recreation Department. Check the County website at [WWW.CCGOV.ORG](http://WWW.CCGOV.ORG) to see what locations we are currently providing Sports and/or Arts Units in. Registration is for a six week unit unless otherwise specified. Classes follow school calendar for holiday closings and inclement weather.

**Cecil Community Center** – Ballet, Tap & Jazz Dance, Hip Hop and Theatre classes. 8 week sessions, Ages 5 and up. Tuesdays & Wednesdays, various times, starting January 12, 2010.

**Thompson Estates Elementary School** – Winter Session, Painting Basics, Thursdays meeting from dismissal – 5pm, 6 weeks, starting January 14<sup>th</sup>, Grades 3-5, \$30.00

**Conowingo Elementary School**—Winter Session, Fit n’ Fun Club, grades 3-5, Mondays and Thursdays from dismissal – 5pm, 8 classes for \$30.00  
Class dates are Jan. 11, 14, (no 18), 21, (no 25), 28, Feb. 1, 4, 8, & 11.

**Homeschool**— Gym Class. Students will play a variety of games to promote health and fitness in a fun atmosphere. Cecil Arena, Thursdays, 8 weeks, Start date Jan. 14, from 1-2 PM, Ages 6-14, \$40 (minimum of 8 students Maximum of 20)

**Parents:** It is your responsibility to contact your child’s school to inform them of the change in dismissal procedure for your child while attending this program, for the dates specified.

Registration for all Sports or Arts Units must be received at the Cecil County Parks and Recreation office at 17 Wilson Road, Rising Sun, MD 21911 prior to first day of Unit. Classes will fill up, so register early to insure a spot. Cancellations must be processed one week before start of program to receive payment. A \$5.00 fee is charged for refunds.
