1	WHEREAS, it is the policy of the State that adults who lack the physical or mental capacity to care		
2	for their basic daily living needs shall have access to and be provided with needed professional services		
3	protect their health, safety and welfare; pursuant to Section 14-102 (Legislative policy and intent) of the		
4	Maryland Annotated Code, Family Law Article, Title 14 (Adult Protective Services); and		
5	WHEREAS, the Maryland Secretary of Human Resources shall develop, supervise, and cause each		
6	local department to implement a program of protective services for vulnerable adults, pursuant to Section		
7	14-201 of the Family Law Article of the Maryland Annotated Code; and		
8	WHEREAS, there shall be at least one review board established in each county, pursuant to Section		
9	14-401(a) of the Family Law Article of the Maryland Annotated Code; and		
10	WHEREAS, the review board shall review each guardianship that a public agency holds at least		
11	once a year and shall conduct a file review at least every six months, pursuant to Section 14-404 of the		
12	Family Law Article of the Maryland Annotated Code; and		
13	WHEREAS, the Adult Public Guardianship Review Board is an interdisciplinary team that acts as a		
14	consultant to the public guardians. They review public guardianship cases every six months and make		
15	recommendations to the court to continue, modify, or terminate guardianship of the person: and		
16	WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County		
17	Executive shall appoint all members of boards and commissions, subject to confirmation by the Council		
18	and		
19	WHEREAS, the County Executive has reappointed Mary Falkenstein to serve on the Adult Public		
20	Guardianship Review Board for a three (3) year term which is to expire on December 31, 2017.		
21	NOW, THEREFORE, BE IT HEREBY RESOLVED that the County Council of Cecil County confirms the		
22	reappointment by the County Executive of Mary Falkenstein to serve on the Adult Public Guardianship		
23	Review Board for a three (3) year term which is to expire on December 31, 2017; and		
24	BE IT FURTHER RESOLVED by the County Council of Cecil County that all provisions of this		
25	Resolution shall take effect on the date that the Resolution is adopted by the Council.
