Appointment – Cecil County Mental Health Core Service Agency Advisory Board

1 **WHEREAS**, Pursuant to Section 10-1201 of Subtitle Core Service Agencies, Title 10 Mental Hygiene
2 Law, in Article X Health- General of the Annotated Code of Maryland, the Core Service Agency is the
3 designated county authority that is responsible for planning, managing, and monitoring publicly funded
4 mental health services; and

5 **WHEREAS**, Pursuant to Section 10-1202(1) of Subtitle Core Service Agencies, Title 10 Mental
6 Hygiene Law, in Article X Health- General of the Annotated Code of Maryland, the Core Service Agency is
7 an agent of a county government which may include a local health department; and

8 **WHEREAS**, Pursuant to Section 10-1202(d)(2) of Subtitle Core Service Agencies, Title 10 Mental
9 Hygiene Law, in Article X Health- General of the Annotated Code of Maryland, the Core Service Agency
10 must incorporate in its method of governance a mechanism for the local county mental health advisory
11 committee to serve as the advisory committee to the core service agency; and

12 **WHEREAS**, the Cecil County Mental Health Core Service Agency Advisory Board was established to
13 assure the existence and access to mental health services for Cecil County;

14 **WHEREAS**, Pursuant to Article 4, Section 412 (b) of the Charter of Cecil County, the County
15 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;
16 and

17 **WHEREAS**, the County Executive has appointed Danielle Ennis to serve on the Cecil County Mental
18 Health Core Service Agency Advisory Board term to expire in December 31, 2017.

19 **NOW, THEREFORE, BE IT HEREBY RESOLVED** that the County Council of Cecil County confirms the
20 appointment by the County Executive of Danielle Ennis to serve on the Cecil County Mental Health Core
21 Service Agency Advisory Board term to expire in December 31, 2017.
