**RESOLUTION NO. 65-2014**  
**Appointments – Animal Care and Control Oversight Committee**

1           **WHEREAS**, the Code of Cecil County, Maryland, Section 142, Article II, §142-2 provides for the  
2 establishment of an Animal Care and Control Oversight Commission; and

3           **WHEREAS**, the Animal Care and Control Oversight Commission shall work with the County's  
4 Animal Care and Control Authority to review current County and state animal laws and recommend  
5 changes in County animal laws, as well as related fees and fines, to the Cecil County Government; and

6           **WHEREAS**, the Animal Care and Control Oversight Commission will review the performance of the  
7 Animal Care and Control Authority as it relates to adherence of contract terms and report findings to the  
8 Cecil County Government; and

9           **WHEREAS**, the Animal Care and Control Oversight Commission will annually review and make  
10 recommendations regarding any changes deemed necessary for either the renewal of the animal care and  
11 control contract, or for the issuance of a request for proposal and subsequent award of the animal care  
12 and control contract, to the Cecil County Government; and

13           **WHEREAS**, the Animal Care and Control Oversight Commission will serve as a review board for  
14 cases involving public or interagency complaints regarding the Animal Care and Control Authority, and will  
15 hear appeals and make decisions regarding license revocation; and

16           **WHEREAS**, each member of the Cecil County government shall appoint one individual from his/her  
17 respective district for a total membership of five (5) individuals to perform the duties as outlined in  
18 Section 142, Article II, of the Code of Cecil County, Maryland; and

19           **WHEREAS**, the terms of the members shall be four years and staggered, except for the initial term,  
20 during which two (2) members, shall respectively serve a two (2) year term, and appointees may serve no  
21 more than two consecutive full terms on the Commission; and

22           **WHEREAS**, Kerrienne Hanlin has resigned from the Animal Care and Control Oversight Committee  
23 effective November 8, 2014; and

24           **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County  
25 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;  
26 and

27           **WHEREAS**, the County Executive has appointed, Mary Rodgers to serve Kerrienne Hanlin's  
28 remaining term to expire on February 19, 2017.
