On motion by Vice President McCarthy, seconded by Councilwoman Bowlsbey, the Council moved to convene in closed session, pursuant to the Annotated Code of Maryland, State Government 10-508(a) (3) to consider the acquisition of real property for a public purpose and matters directly related thereto. The motion was approved unanimously.

Mr. Wein and Mr. Robinson discussed the administration's proposal to purchase real property.

On motion made by Vice President McCarthy, seconded by Councilwoman Bowlsbey, the Council moved to adjourn the closed session at 10:17 a.m. The motion was approved unanimously.

Approval of Minutes

On a motion made by Vice President McCarthy, seconded by Councilman Schneckenburger, the Council moved to approve the minutes of the Council work session of September 15, 2015. Motion was carried by a vote of 4 to 0. Councilman Patchell was absent.

September 22, 2015 Work Session Meeting - Page 1

On a motion made by Vice President McCarthy, seconded by Councilwoman Bowlsbey, the Council moved to approve the minutes of the Council closed session of September 15, 2015. Motion was carried by a vote of 4 to 0. Councilman Patchell was absent.

Proposed North East Library

Denise Davis, Library Director, gave a presentation about the proposed North East Library. Ms. Davis explained that the proposed 45,000 SF building will house a public library of 30,000 SF and library office headquarters of 15,000 SF, which will free up space in the existing Elkton Library and relieve parking congestion. She stated that construction costs are about \$330 per square foot. She is hopeful to receive \$5M from state grants to be used for this construction project.

Council President Hodge asked Ms. Davis to provide a list of activities and functions of library headquarters.

Questions and comments ensued. Morgan Miller, Deputy Director; and Ken Wiggins, Chairman of the Board of Library Trustees also participated in the presentation.

County Employee Health Benefit Changes

Donna Nichols, Director of Human Resources, introduced Mike Shuster from Willis of Maryland. Mr. Schuster is the broker for the county's health benefits. Ms. Nichols described a new option for employees to have a High Deductible Health Plan for employees who wish to minimize their premium. Ms. Nichols also discussed the Pharmacy Management Plan that employees can choose where they obtain prescriptions. The County has renegotiated a new prescription plan with Express Script, which is estimated to save \$3M over three years. Mr. Schuster and Ms. Nichols also described how the "Cadillac tax" will hurt employers whose health plans are above an allowed cost. Questions and comments ensued.

Consolidated Transportation Plan - Follow up

Council President Hodge led a discussion of the Consolidated Transportation Plan meeting held on September 17, 2015. After discussion of the Route 222/95 bridge widening project, the Council agreed by consensus to request the administration work with the State Highway Administration to clarify whether the State will allow economic growth in this area without an expansion of this bridge.

State legislative Initiatives - Follow up

The Council expressed their appreciation that the state delegation was very receptive of the county's initiatives. Senator Norman agreed to pre-file several initiatives. The Council also discussed whether local pharmacists should approach the State about their dissatisfaction with prescription business management firms.

Dispensary License

The Council discussed the issue of distillery license, which had been mentioned at the State legislative initiatives meeting. Earl Bradford, Chief, Alcoholic Beverage Inspector, Liquor Control Board, provided information of a similar law in Worcester County.

Council Manager Report

Mr. Massey reminded the Council that there will be no work session on September 29, which is the fifth Tuesday of the month. He also stated that the tour of the Courthouse is confirmed on Thursday, October 8 at 10am. Presentations on Elkton West and Artesian Water have been scheduled at the Council work session of October 13. He also reminded the Council of the Upper Shore Regional Council Retreat on September 24, Hollywood Casino re-ribbon cutting on September 25, and several community events on September 26.

Council Member Items

Councilman Schneckenburger had no comments.

Vice President McCarthy reminded the public of the Sassafras River Bridge closing. He also stated that he attended the Elkton Fall Festival.

Councilwoman Bowlsbey attended the Early Childhood Advisory Council and Planning Commission.

President Hodge stated that the detour around the Sassafras River Bridge was twenty-two miles. He suggested a short cut using Wards Hill Road.
