# **Approval of Minutes**

On a motion made by Vice President McCarthy, seconded by Councilman Schneckenburger, the Council moved to approve the minutes of the Council work session of September 8, 2015. Motion carried unanimously.

# Conflict in Council Work Session Schedule - October 27

Mr. Massey explained that the Council work session on October 27 will conflict with Secretary Gill's economic development site visit and roundtable discussion, which the Council has been invited. After discussion, the Council agreed that the work session may be cancelled or rescheduled pending any urgent business.

#### 2016 Council Schedule

Mr. Massey provided a revised 2016 schedule for review. The budget hearing schedule was revised so that evening hearings can be held on Tuesdays when the Council is not meeting in legislative session in April and May. On legislative session days, budget hearings will be held during the afternoon. The length of the budget hearing is approximately two hours. The Council approved of the 2016 schedule by consensus.

# Review of Legislative Agenda

Council President Hodge led a review of the legislative agenda.

Mr. Wein provided information about Resolution No. 52-2015 Supplemental Appropriation -Casino Local Impact Fund - Various Grants, which will be introduced at tonight's session. Questions and comments ensued.

The Council discussed Bill No. 2015-18 Animal Care and Control Ordinance, which will be considered for final reading. Three amendments have been introduced.

Councilwoman Bowlsbey suggested that the number of citizens appointed should be increased from one to two by the Executive and Council, which will result in a board composition of seven members.

Mr. Allison explained how a conflict of interest issue will be handled. The Council discussed the importance of appointing qualified citizens.

The Council agreed by consensus to support Councilwoman Bowlsbey's amendment to increase the number of appointed citizens from one to two, who will be appointed by the Council and Executive. This amendment will be drafted as Amendment No. 4 to Bill No. 2015-18.

# **COUNCIL MANAGER REPORT**

Mr. Massey reminded the Council of today's dedication of the School of Technology and Congressman Harris' roundtable on HIDTA funding. In addition, Judge Baynes and Matthew Barrett, Court Administrator, asked the Council to tour the Courthouse and discuss their challenges. The Council agreed that Mr. Massey can finalize a date for the visit. The Council prefers that the tour is scheduled on Tuesday after a work session.

#### **COUNCIL MEMBER ITEMS**

Councilman Schneckenburger attended the Regional Apparatus Showcase on Main Street in Elkton where the Singerly Fire Company displayed their new fire equipment. He also commented about a possible bus route linking Newark to Perryville train stations, which MTA has initiated.

Councilwoman Bowlsbey attended the College scholarship breakfast, the College's Little Black Dress fundraiser, Local Management Board meeting, Lobsterfest fundraiser for the Union Hospital Foundation's hospice, Commission on Aging meeting and Early Childhood Advisory Board. She also participated in Thank a Hero 9-11 project on September 11.

Councilman Patchell also participated in Thank a Hero 9-11 project. He is serving as a chaperone for the children attending North Bay this week.

Vice President McCarthy attended the College scholarship breakfast and Lions Club fundraiser.

Council President Hodge commented on attending the Regional Apparatus Showcase and the new rescue truck, purchased by Singerly Fire Company, which cost over one million dollars. He stated that fire companies receive tax support for this equipment and other services, which are invaluable to our community.
