**Title of Bill:** Budget Amendment - Capital Budget - Animal Care and Control Facility

**Synopsis:** A Bill to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2016 that will increase bond budget authority within the Approved General Fund Capital Improvement Program budget by \$500,000 in order to purchase real property and existing improvements, and acquire necessary equipment for, an animal care and control facility and further, for the purpose of providing financial savings versus the existing rental arrangement.

## Budget Amendment - Capital Budget - Animal Care and Control Facility

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2015, the County  
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2016; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held  
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2016; and

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 2, 2015, the  
6 County Council adopted the budget for Fiscal Year 2016; and

7           **WHEREAS**, the County Executive is revising the Fiscal Year 2016 Capital Budget to increase the  
8 revenue and expenditure authority for Cecil County, Maryland to in order create a project known as  
9 "Acquire Animal Care and Control Facility Cecil County, Maryland"; and

10           **WHEREAS**, through the efforts of staff to determine cost effective solutions to provide financial  
11 savings for the exiting rented facility, an opportunity has been presented to acquire an entire facility; and

12           **WHEREAS**, the acquisition of said facility is estimated to provide approximately \$ 1,175,964 in  
13 savings over the next 20 years, and also provides a long-term commitment by the County to provide the  
14 highest quality animal care and control possible for the citizens of Cecil County; and

15           **WHEREAS**, such appropriation is necessary to provide bond budget authority of \$500,000 to  
16 accommodate the acquisition of the property, provide for estimated closing costs, and to provide funding  
17 to repair, and purchase necessary equipment for an immediate animal care and control need.

18           **NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, IN**  
19 **LEGISLATIVE SESSION** that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for  
20 Fiscal Year 2016 is hereby amended to increase bond budget authority within the Approved General Fund  
21 Capital Improvement Program budget by \$500,000 from in order to purchase real property and existing  
22 improvements and to undertake capital repairs, and acquire necessary equipment for, an animal care and  
23 control facility.

24           **AND BE IT FURTHER ENACTED** that this Act shall take effect 60 calendar days from the date it  
25 becomes law.
