1       **WHEREAS**, Cecil County has a landfill enterprise fund and, as such, must operate as a business and  
2       set fees and rates to cover all expenses; and

3       **WHEREAS**, Section 285 of the Cecil County Code authorizes the County to charge licensing and  
4       service fees and penalties related to the proper disposal of solid waste for the maintenance of the  
5       solid waste management system and landfills.

6       **NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,**

- 7       1.       That the attached Solid Waste Management Division Fee Schedule (Scales in Service) as  
8               Appendix A and, the attached Solid Waste Management Division Fee Schedule (Scales not  
9               in Service) as Appendix B are hereby adopted effective July 1, 2016 to cover the expenses  
10              of the Cecil County Solid Waste Management System; and,  
11       2.       That the County Executive, the Director of Public Works, and the Director of Finance will  
12              cause the fees, rates and penalties to be collected in the manner provided by law.

13       **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,** that  
14       the fees, rates, and penalties shall be effective July 1, 2016 and shall continue in effect until  
15       changed under the laws of the State of Maryland and/or Cecil County.
