Title of Bill: Budget Ordinance FY2014 - Transfer of Bond Appropriations - Board of Education - Capital Projects.

Synopsis: A bill to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for FY2014 to transfer existing bond appropriation authority within the Board of Education Capital Budget in the amount of \$15,335.02 from completed School Capital Projects to active projects for the fiscal year ending June 30, 2014.

Amendment - Budget Ordinance FY2014 -Transfer of Bond Appropriations

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on March 1, 2013, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2014; and,

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2014; and,

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on May 21, 2013, the
6 County Council adopted the budget for Fiscal Year 2014; and,

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2014 Capital Budget to transfer the
8 unencumbered bond revenue and expense for Cecil County, Maryland resulting from completed and closed
9 capital projects, and transfer said bond revenue and expense to active projects, the following amounts
10 within the Capital Projects Funds are to be transferred:

11 (1) To transfer \$5,900.74 bond revenue and expense to the North East High Lighting Project from
12 the completed North East High Elevator project; and

13 (2) To transfer \$9,434.28 bond revenue and expense to the North East High Lighting Project from
14 the completed North East High Bleacher Replacement project; and

15 **WHEREAS**, such appropriation is necessary to provide additional bond funding of \$15,335.02 to the
16 North East High Lighting Project to fund running underground wiring to light poles, some unforeseen pole
17 replacement and wiring to wall packs that had to be re-done in order to meet code; and

18 **WHEREAS**, pursuant to Section 510(b) of the Cecil County Charter, the County Executive has now
19 recommended a transfer of bond appropriations to the Budget Ordinance for the fiscal year ending
20 June 30, 2014; and

21 **WHEREAS**, Section 506 of the Charter of Cecil County requires that no final budget action may be
22 taken by the County Council until after public hearing or hearings have been held in open public session.

23 **NOW THEREFORE, BE IT HEREBY RESOLVED** that the Annual Budget and Appropriation Ordinance for
24 Cecil County, Maryland for Fiscal Year 2014 is hereby amended for the transfer of bond appropriations,
25 within the Board of Education Capital Projects Fund of \$15,335.02.
