Emergency Legislation - Amendment –Budget Ordinance FY 2014 - Snow Removal WHEREAS, in accordance with Section 505 of the Cecil County Charter, on March 1, 2013, the County Executive submitted a proposed budget to the County Council for Fiscal Year 2014; and,

WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2014; and,

WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on May 21, 2013, the County Council adopted the budget for Fiscal Year 2014; and,

WHEREAS, the County Executive is revising the Fiscal Year 2014 General Fund Budget revenue estimate for Cecil County to increase the amount of fund balance available by \$400,000; and establish the following amounts within the General Fund as follows:

a) The addition of \$400,000 in expense for County Roads Maintenance snow removal to protect County citizens traveling County maintained roads; and,

WHEREAS, such appropriation is necessary to provide \$400,000 from fund balance for the General Fund expenditures; and

WHEREAS, Section 506 of the Charter of Cecil County requires that no final budget action may be taken by the County Council until after public hearing or hearings have been held in open public session: and,

NOW THEREFORE, BE IT HEREBY RESOLVED that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal Year 2014 is hereby amended for the supplemental appropriation and by amending the Current Expense Budget to appropriate additional expenditures in the General Fund to increase the General Fund by the amount of \$400,000.
