**Title of Bill:** Budget Ordinance FY 2014 – Board of Education – Perryville High School Track Replacement

**Synopsis:** A bill to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2014 in order to increase the expenditure authority for the Cecil County Board of Education allocation within the General Fund, to provide for a \$250,000 front-funded grant to be expended for the Perryville High School Track Replacement project.

Budget Ordinance FY 2014 – Board of Education – Perryville High School Track Replacement

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on March 1, 2013, the  
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2014; and,

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held  
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2014; and,

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on May 21, 2013, the  
6 County Council adopted the budget for Fiscal Year 2014; and,

7           **WHEREAS**, the County Executive is revising the Fiscal Year 2014 General Fund Budget revenue  
8 estimate for Cecil County to increase the amount of fund balance available by \$250,000; and establish the  
9 following amount within the General Fund as follows:

10           a) The addition of a \$250,000 in expenditure authority for a front-funded grant to the Cecil  
11 County Board of Education in order to replace the track at Perryville High School that has been  
12 declared by that Board as unfit for use; and,

13           **WHEREAS**, such appropriation is necessary to provide \$250,000 from fund balance for the General  
14 Fund expenditures; and

15           **WHEREAS**, such grant allocation will be awarded to Cecil County Board of Education prior to the  
16 beginning of the construction of the track, and is limited to the amount of the award; and,

17           **WHEREAS**, any grant funds that are unused at the end of the construction of the Perryville High  
18 School track will be returned to Cecil County; and,

19           **WHEREAS**, Section 506 of the Charter of Cecil County requires that no final budget action may be  
20 taken by the County Council until after public hearing or hearings have been held in open public session:  
21 and,

22           **NOW THEREFORE, BE IT HEREBY RESOLVED** that the Annual Budget and Appropriation Ordinance  
23 for Cecil County, Maryland for Fiscal Year 2014 is hereby amended for the supplemental appropriation and  
24 by amending the Current Expense Budget to appropriate additional expenditures in the General Fund to  
25 increase the General Fund by the amount of \$250,000.
