Synopsis: A Bill amending Section 45-1 of the County Code to eliminate the 2% discount for payment of property taxes in July; and to provide authority for the County Council to establish an annual discount for payment of property tax by resolution.

1 **WHEREAS**, Part I, Chapter 45 (Finance and Taxation), § 45-1 (Collection of taxes), subsection (H), of
2 the Cecil County Code provides that, upon payment in full of a County property tax bill in the month of
3 July, and on the first semiannual installment payment of a County property tax bill in the month of July,
4 there shall be a discount of 2% of said bill, and upon payment in full of a County property tax bill in the
5 month of August, and on the first semiannual installment payment of a County property tax bill in the
6 month of August, there shall be a 0% discount in the amount of the property tax; and,

7 **WHEREAS**, modification of the discount provided for under § 45-1(H) of the Cecil County Code
8 must presently be accomplished by the passage of a Bill amending the Cecil County Code; and,

9 **WHEREAS**, the County desires to reduce the time and expense involved with enacting a Bill
10 amending the Code each time that it is deemed necessary and proper to modify the discount provided for
11 under § 45-1(H) by authorizing the discount to be established by resolution of the County Council.

12 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, IN**
13 **LEGISLATIVE SESSION**, that Part I, Chapter 45 (Finance and Taxation), § 45-1 (Collection of taxes),
14 subsection (H), of the Cecil County Code is amended as follows:

15 § 45-1 (Collection of taxes)
16 (H) Upon payment in full of a County property tax bill in the month of July, and on the
17 first semiannual installment payment of a County property tax bill in the month of July, there shall
18 be a discount of [2%] 0% of said bill, and upon payment in full of a County property tax bill in the
19 month of August, and on the first semiannual installment payment of a County property tax bill in
20 the month of August, there shall be a 0% discount in the amount of the property tax.

21 THE DISCOUNTS SET FORTH HEREIN MAY BE ESTABLISHED ANNUALLY BY RESOLUTION OF THE
22 COUNCIL.

23 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
24 the amendments set forth herein shall be effective July 1, 2015 and shall continue in effect until changed
25 by the County Council.
