Synopsis: A Bill amending Section 45-1 of the County Code to eliminate the 2% discount for payment of property taxes in July; and to provide authority for the County Council to establish an annual discount for payment of property tax by resolution.

WHEREAS, Part I, Chapter 45 (Finance and Taxation), § 45-1 (Collection of taxes), subsection (H), of the Cecil County Code provides that, upon payment in full of a County property tax bill in the month of July, and on the first semiannual installment payment of a County property tax bill in the month of July, there shall be a discount of 2% of said bill, and upon payment in full of a County property tax bill in the month of August, and on the first semiannual installment payment of a County property tax bill in the month of August, there shall be a 0% discount in the amount of the property tax; and,

WHEREAS, modification of the discount provided for under § 45-1(H) of the Cecil County Code must presently be accomplished by the passage of a Bill amending the Cecil County Code; and,

WHEREAS, the County desires to reduce the time and expense involved with enacting a Bill amending the Code each time that it is deemed necessary and proper to modify the discount provided for under § 45-1(H) by authorizing the discount to be established by resolution of the County Council.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that Part I, Chapter 45 (Finance and Taxation), § 45-1 (Collection of taxes), subsection (H), of the Cecil County Code is amended as follows:

§ 45-1 (Collection of taxes)

(H) Upon payment in full of a County property tax bill in the month of July, and on the first semiannual installment payment of a County property tax bill in the month of July, there shall be a discount of [2%] 0% of said bill, and upon payment in full of a County property tax bill in the month of August, and on the first semiannual installment payment of a County property tax bill in the month of August, there shall be a 0% discount in the amount of the property tax.

THE DISCOUNTS SET FORTH HEREIN MAY BE ESTABLISHED ANNUALLY BY RESOLUTION OF THE COUNCIL.

AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the amendments set forth herein shall be effective July 1, 2015 and shall continue in effect until changed by the County Council.
