5	develop and operate a rental housing development comprised of approximately 76 units, known as
6	Riverwoods at North East and located at 125 Railroad Lane, in Cecil County, Maryland (the "Project"), all or a
7	portion of which will assist families of low or limited income as required by applicable law or regulations;
