1       **WHEREAS**, the Environment Article of the Annotated Code of Maryland requires the County to have  
2 a Master Water & Sewer Plan and provides for the Administration, enforcement, and amendment of Plan;  
3 and

4       **WHEREAS**, an amendment to the Master Water & Sewer Plan, Chapter 3, §3.2.11 Artesian Water  
5 Maryland, Inc., Section B. has been proposed and on February 20, 2013 the Planning Commission  
6 recommended approval of the proposed amendment.

7       **NOW, THEREFORE, BE IT HEREBY RESOLVED** by the County Council of Cecil County, Maryland, that  
8 the text amendment to the Master Water & Sewer Plan, , Chapter 3, §3.2.11 Artesian Water Maryland, Inc.,  
9 Section B. is hereby adopted as follows:

11 B. Proposed Improvements

12 Artesian Water Maryland, Inc. will construct a 20" water main from the Maryland/Delaware line  
13 at Red Hill Road to the intersection of U.S. Route 40 and Maryland Route 279 and will extend a  
14 water main north to serve the Cherry Hill portion of its franchise. The 20" water main will have  
15 the capability of conveying 5.0 mgd to the franchise area. IN ADDITION TO SERVING THE W.L. GORE CHERRY  
16 HILL FACILITY, KENMORE ELEMENTARY SCHOOL, AND CHERRY HILL MIDDLE SCHOOL, THE WATER MAIN  
17 SHALL PROVIDE SERVICE TO PROPERTIES ON THE EAST SIDE OF SINGERLY ROAD WHOSE OWNERS ARE  
18 PROVIDED WITH BOTTLED WATER DUE TO ELEVATED TCE LEVELS IN THEIR WELLS.



21 Department of the Environment for its approval pursuant to §9-507 of the Environment Article of the  
22 Annotated Code of Maryland.



Amendment - Master Water and Sewer Plan, Artesian Water, MD




