1	WHEREAS, Section 6-302 of the Tax-property Article of the Annotated Code of Maryland requires
2	the governing body of each county to annually set the tax rate for the next taxable year; and
3	WHEREAS, Section 508 of the Charter of Cecil County requires that County Council shall levy the
4	amount of taxes required by the Budget to ensure that the Budget is balanced so that proposed revenues
5	equal proposed expenditures.

7	NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, IN
8	LEGISLATIVE SESSION, as follows:
9	1. That a County property tax for the taxable year beginning July 1, 2013 and ending June 30, 2014, is
10	hereby levied and imposed on all assessments, persons or property subject to ordinary taxation in Cecil
11	County; and that the rate of County taxation for such taxable year for real property is hereby fixed at
12	Ninety-nine and Seven Hundredths Cents (\$.9907) on each \$100 of assessed valuation of such property;
13	2. That the County Executive and Director of Finance will cause the property tax to be collected in the
14	manner provided by law.
15	AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, IN
16	LEGISLATIVE SESSION that the property tax rate shall be effective July 1, 2013 and shall continue in effect
17	until changed under the laws of the State of Maryland and/or Cecil County.
