4	WHEREAS, the County Executive is revising the Fiscal Year 2103 General Fund revenue estimate for
5	Cecil County to establish the amount of the Bryne Justice Assistance grant funds from the U.S. Department
6	of Justice by \$36,915 pursuant to an award notification: and
7	WHEREAS, such appropriation is necessary to provide \$36,915 grant funding for Bryne Justice
8	Assistance Grant Program expenditures.
9	NOW THEREFORE, BE IT HEREBY RESOLVED that the Annual Budget and Appropriation Ordinance
10	for Cecil County, Maryland General Fund for Fiscal Year 2013 is hereby amended and finally adopted by
11	amending the Current Expense Budget to appropriate additional expenditures in the General Fund to
12	increase the Law Enforcement Division of the Sheriff's Office by the amount of \$36,915.

14	Ordinance for Cecil County, Maryland for Fiscal Year 2013 is adopted and is deemed effective as of the date
15	of its passage by County Council and approval by the County Executive.
