Amendment – Budget Ordinance FY2013 – Protective Order Advocacy and Representation Project

1           **WHEREAS**, the County Executive has recommended a supplemental appropriation to the budget for  
2 the fiscal year ending June 30, 2013, in accordance with Section 511 of the Charter of Cecil County,  
3 Maryland; and

4           **WHEREAS**, the County Executive is revising the Fiscal Year ~~2013~~ General Fund revenue estimate for  
5 Cecil County to establish the amount of the Protective Order Advocacy and Representation Project grant  
6 funds from the Maryland Department of Family Administration by \$25,127 pursuant to an award  
7 notification: and

8           **WHEREAS**, such appropriation is necessary to provide \$25,127 grant funding for the Protective  
9 Order Advocacy and Representation Project Grant Program expenditures.

10           **NOW THEREFORE, BE IT HEREBY RESOLVED** that the Annual Budget and Appropriation Ordinance  
11 for Cecil County, Maryland for Fiscal Year 2013 is hereby amended and finally adopted by amending the  
12 Current Expense Budget to appropriate additional expenditures in the General Fund to increase the Social  
13 Services Department by the amount of \$25,127.

14           **AND BE IT FURTHER RESOLVED** that the amended Annual Budget and Appropriation  
15 Ordinance for Cecil County, Maryland for Fiscal Year 2013 is adopted and is deemed effective as of the date  
16 of its passage by County Council and approval by the County Executive.


