WHEREAS, Cecil County officials developed the 2011 – 2014 Cecil County Local Impact Grant Multi-Year Plan in conjunction with the Local Development Council for improvements in the local community in the areas of infrastructure, facilities, public safety, sanitation, economic and community development, and other public services and improvements; and

WHEREAS, through the Local Impact Grant Multi-Year Plan, county officials established and designated specific funds for a competitive Video Lottery Terminal (VLT) Local Community Grant Program to allow not-for-profit organizations and municipalities to compete for grant funds, which was expanded county-wide in 2012; and

WHEREAS, the VLT Local Community Grant Program was developed and administered by staff in the Commissioners' Office and the Board of County Commissioners provided oversight and direction for the grant process; and

WHEREAS, the Board of County Commissioners is now the County Council of Cecil County under Charter government; and

WHEREAS, the grant process includes working with the appointed Grant Review Committee, developing the grant review, evaluation, and ranking system for the committee members, developing and executing the grant award contracts, monitoring the grant contracts and reports, reviewing the progress, evaluating projects, and reporting progress to county officials; and

WHEREAS, the grant process that has been established to approve and manage the VLT Local Community Grant Program has been implemented successfully; and

WHEREAS, continuing the administration and management of the VLT Local Community Grant Program under the County Council of Cecil County would continue to provide the public the opportunity to participate in the process and provide comments on projects and programs; and

WHEREAS, the County Council members would provide more checks and balances for the community grant process by continuing to provide elected officials representing their respective district the opportunity to present input and offer recommendations on proposed local community grant projects and programs.
