2	the chief legal officer of the County, and be a legal advisory to the County Council; and
3	WHEREAS, The County Executive appointed Jason Allison as the County Attorney, which was
4	confirmed by the County Council on January 15, 2015, and
5	WHEREAS, Mr. Allison has provided sound legal opinions and advice to the County Council; and
6	WHEREAS, the County Council recognizes that the County Attorney must also represent the
7	County Executive, all departments and other instrumentalities of the County Government in Cecil County;

9	WHEREAS, Section 213 of the Charter of Cecil County provides that the County Council may by
10	resolution, at its discretion and subject to the provisions of its budget or supplementary appropriations,
11	employ legal advisors as it deems necessary to perform its functions; and
12	WHEREAS, the County Council solicited expressions of interest for an attorney to provide legal
13	services; and
14	WHEREAS, the Council approved Funk and Bolton as special counsel for use when the Council
15	Attorney is unable or when a subject specialist is needed for a specific purpose.
16	WHEREAS, Clara E. Campbell Law Offices has served the Cecil County Planning Commission and
17	assisted the Department of Planning and Zoning with issues of zoning and land usage.

19	NOW, THEREFORE, BE IT HEREBY RESOLVED that the County Council of Cecil County designates
20	Jason Allison for general legal opinions and advisor; and
21	BE IT FURTHER RESOLVED that the County Council of Cecil County designates Funk and Bolton for
22	special counsel; and
23	BE IT FURTHER RESOLVED that the County Council of Cecil County designates Clara E. Campbell to
24	assist the Council in Rezoning Hearings.
