WHEREAS, pursuant to Tax Property Article of the Annotated Code of Maryland, Title 3, Section 3-102 1 there is a property tax assessment appeal board in each county; and 2 WHEREAS, pursuant to Tax Property Article, Title 3; Section 3-103(a), the Property Tax Assessment 3 Appeal Board is comprised of three members and one alternate members, who are appointed by the 4 5 Governor, and WHEREAS, the Governor appoints the members from a list of names, as submitted by the County 6 7 Executive with the approval of the County Council; pursuant to Section 3-103(a) and WHEREAS, the term of a member is five years and ends on June 1 of the appropriate year, but a 8 member continues to serve until a successor is appointed and qualifies, pursuant to Section 3-103(c)(2); and 9 WHEREAS, the Property Tax Assessment Appeal Board has jurisdiction over appeals concerning real 0 property values and assessments, credits for elderly or disabled renters, credits for homeowners, credits for 1 elderly or disabled homeowners, credits for real property leased to a religious group or religious organization, 2 value of agricultural easements, and the rejection of an application for property tax exemption; pursuant to 3 Section 3-107(a); and WHEREAS, pursuant to Section 412(b) of the Charter of Cecil County, the Executive shall appoint all 5 members of boards and commissions and that such membership shall be subject to confirmation by the 6 Council; 7 WHEREAS, the County Executive has appointed Robert Litzenberg, Jr. to serve on the Cecil County 8 Property Tax Assessment Appeal Board to fill the vacancy of Henry Mason term to expire on June 2, 2018. 9 NOW, THEREFORE, BE IT HEREBY RESOLVED that the County Council of Cecil County confirms the 0 appointment by the County Executive of Robert Litzenberg, Jr. to serve on the Cecil County Property Tax 1 Assessment Appeal Board to fill the vacancy of Henry Mason term to expire on June 2, 2018. 2 AND BE IT FURTHER RESOLVED by the County Council of Cecil County that all provisions of this 3 Resolution shall take effect on the date that the Resolution is adopted by the Council.
