2 guidance on implementation strategies within Cecil County to meet pollution reduction goals established for
3 the county by the State of Maryland; and

4 **WHEREAS**, On December 31, 2010 the U.S. Environment Protection Agency (EPA) set limits on the
5 amount of nutrients and sediment that can enter the Chesapeake Bay; and

6 **WHEREAS**, EPA required states within the Bay watershed to develop statewide Watershed
7 Implementation Plans; and

8 **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County Executive
9 shall appoint all members of boards and commissions, subject to confirmation by the Council;
