WHEREAS, a local jurisdiction may establish by local law a planning commission with the powers and duties, pursuant to Section 2-101. Authority to establish, Subtitle 1. Organization and General Authority, Title 2. Planning Commission, Division I. Single-Jurisdiction Planning and Zoning, in the Land Use Article of the Annotated Code of Maryland,; and

WHEREAS, the Cecil County Board of Appeals shall consist of five regular members and one alternate member, who must be residents of Cecil County; pursuant to Section 9-704 Board of Appeals, Subtitle 7. Cecil County, Title 9. Single-Jurisdiction Planning and Zoning, in the Land Use Article of the Annotated Code of Maryland; and

WHEREAS, the Cecil County Board of Appeals shall be appointed by the County Executive and approved by the County Council, pursuant to Section 298. Board of Appeals Established, Part II. Board of Appeals, Article XVI. Administrative Mechanisms, of the Cecil County Zoning Ordinance; and

WHEREAS, the power and duties of the Board of Appeals are to hear and decide appeals when it is alleged that there is an error in any order, requirement, decision, or determination made by the Zoning Administrator or any other administrative official in the enforcement of the zoning ordinance; and to hear and decide special exceptions as provided in the zoning ordinance; and to authorize upon application a variance from the provisions of the zoning ordinance; and

WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;

WHEREAS, The County Executive approves the appointment of Brad Carrillo to the Board of Appeals for a three year term to expire in August 2017.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the County Council of Cecil County confirms the appointment Brad Carrillo to the Board of Appeals for a three year term to expire in August 2017.
