1           **WHEREAS**, Title 3, Subtitle 5, Section 3-503 of the Annotated Code of Maryland defines the duties  
2 and functions of a local Social Services Board as an advisory board to the local director for the local  
3 application and implementation of State policies or procedures, which includes evaluating and making  
4 recommendations to improve current services and develop new services as needed in the county; and  
5 serving as the liaison with the local government authority and residents to communicate the objectives,  
6 policies and programs of local social services and public assistance administration; and

7           **WHEREAS**, Cecil County Department of Social Services Board Members' Randy Bailey and Deron  
8 Brown have fulfilled their two statutory terms as of June 30, 2014; and

9           **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County  
10 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;  
11 and

12           **WHEREAS**, the County Executive has appointed Raymond Hamm and Berkeley C. Orr, Jr. to serve  
13 on the Department of Social Services Board; and

14           **NOW, THEREFORE, BE IT HEREBY RESOLVED** that the County Council of Cecil County confirms the  
15 appointment by the County Executive of Raymond Hamm and Berkeley C. Orr, Jr. to serve on the  
16 Department of Social Services Board to for a three year term to expire on June 30, 2017; and


17           **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by  
18 the County Council of Cecil County, Maryland.
