## Appointment—Public Safety Pension Plan Board of Trustees

1           **WHEREAS**, the Cecil County Board of Commissioners established the County Pension Plan for Public  
2 Safety employees by Resolution on April 16, 2002; and

3           **WHEREAS**, the Public Safety Pension Plan was established to benefit the Cecil County's Public Safety  
4 Employees; and

5           **WHEREAS**, the purpose of the Plan is to attract and retain the highest quality public safety  
6 employees and to provide the Plan's participants with retirement benefits in accordance with the terms,  
7 conditions, and provisions of the Plan, as set forth in the Plan Document, the Trust Agreement, and  
8 applicable law; and

9           **WHEREAS**, pursuant to Article 7 Administration of the Plan, Section 7.1 Board of Trustees, the  
10 Pension Plan for Public Safety Employees designates a Board of Trustees as the administration of the Plan;  
11 and

12           **WHEREAS**, the Board of Trustee has oversight and day-to-day administration authority of the Public  
13 Safety Pension Plan; and

14           **WHEREAS**, The Board of Trustees member shall be required to select, monitor, and diversify the  
15 assets of the Pension Plan in accordance with the standards outlines in the Plan and Trust Agreement; and

16           **WHEREAS**, Article 7, Section 7.1 Board of Trustees, Subsection (a) (i) specifies that the Board of  
17 Trustees will consist of one County employee or officer designated by the County Executive; the Director of  
18 Finance or his or her designee; the Cecil County Sheriff or his or her designee; the Director of Emergency  
19 Services or his or her designee; the Human Resources Director or his or her designee; one member who is  
20 an active Participant designated by the Cecil County Sheriff, who must be a law enforcement employee;  
21 one member who is an active Participant designated by the Cecil County Sheriff, who must be a corrections  
22 employee; one member who is an active Participant designated by the Director of Emergency Services; one  
23 member of the public who has financial management expertise who shall be designated by the County  
24 Executive; and

25           **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County  
26 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;  
27 and

28           **WHEREAS**, Sheriff Adams has recommended that Bruce W. Diehl, Corrections Representative, to be  
29 appointed and Angie Blodgett, Law Enforcement Representative, to be reappointed to the Public Safety  
30 Pension Plan Board of Trustees; and

31           **WHEREAS**, The County Executive approves the appointment of Bruce W. Diehl and the  
32 reappointment of Angie Blodgett to the Public Safety Pension Plan Board of Trustees.

33           **NOW, THEREFORE, BE IT HEREBY RESOLVED** that the County Council of Cecil County confirms the  
34 appointment of Bruce W. Diehl, term to expire on December 2017, and Angie Blodgett, term to expire on  
35 December 2018, to the Public Safety Pension Plan Board of Trustees.

36           **BE IT FURTHER RESOLVED** by the County Council of Cecil County that all provisions of this  
37 Resolution shall take effect on the date the Resolution is adopted by the Council.
