WHEREAS, Pursuant to a Memorandum of Understanding between the Maryland Department of Agriculture and Cecil County, which was approved by the Cecil County Board of Commissioners on March 16, 2010, the Cecil County Board of County Commissioners agreed to appoint a Weed Advisory Committee to assist the Department of Agriculture in developing and implementing a Noxious Weed Control Program; and

WHEREAS, the Weed Advisory Committee of Cecil County works with the Roads Division of the Department of Public Works in providing oversight for the weed control program, and

WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County Executive shall appoint all members of boards and commissions, subject to confirmation by the Council; and

WHEREAS, the County Executive has appointed Monty Johnson and Dottie Mortimer and reappointed Anthony Calao, William Ewing, Dave Hollenbaugh, Charles Robinson, Peter Rupp, Mike Scheeler, Mark Smith and Dan Webber to the Weed Control Board for a one (1) year term, to expire April 1, 2016.
