1           **WHEREAS**, Pursuant to Maryland Annotated Code, Agriculture Article, Section 9-2402(4), the  
2 Secretary of Agriculture may enter into agreements with any county or subdivision of the State to effect a  
3 program of control and eradication of noxious weeds; and

4           **WHEREAS**, Pursuant to a Memorandum of Understanding between the Maryland Department of  
5 Agriculture and Cecil County, which was approved by the Cecil County Board of Commissioners on March  
6 16, 2010, the Cecil County Board of County Commissioners agreed to appoint a Weed Advisory  
7 Committee to assist the Department of Agriculture in developing and implementing a Noxious Weed  
8 Control Program; and

9           **WHEREAS**, the Weed Advisory Committee of Cecil County works with the Roads Division of the  
10 Department of Public Works in providing oversight for the weed control program, and


11           **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County  
12 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;  
13 and

14           **WHEREAS**, the County Executive has appointed Monty Johnson ~~and Dottie Mortimer~~ and  
15 reappointed Anthony Calao, William Ewing, Dave Hollenbaugh, Charles Robinson, Peter Rupp, Mike  
16 Scheeler, Mark Smith and Dan Webber to the Weed Control Board for a one (1) year term, to expire April  
17 1, 2016.

18           **NOW, THEREFORE, BE IT HEREBY RESOLVED** that the County Council of Cecil County confirms the  
19 appointment by the County Executive of Monty Johnson ~~and Dottie Mortimer~~ and the reappointment of  
20 Anthony Calao, William Ewing, Dave Hollenbaugh, Charles Robinson, Peter Rupp, Mike Scheeler, Mark  
21 Smith and Dan Webber to the Weed Control Board for a one (1) year term, to expire April 1, 2016.
