WHEREAS, Pursuant to Section 10-1201 of Subtitle Core Service Agencies, Title 10 Mental Hygiene Law, in Article X Health- General of the Annotated Code of Maryland, the Core Service Agency is the designated county authority that is responsible for planning, managing, and monitoring publicly funded mental health services; and

WHEREAS, Pursuant to Section 10-1202(1) of Subtitle Core Service Agencies, Title 10 Mental Hygiene Law, in Article X Health- General of the Annotated Code of Maryland, the Core Service Agency is an agent of a county government which may include a local health department; and

WHEREAS, Pursuant to Section 10-1202(d)(2) of Subtitle Core Service Agencies, Title 10 Mental Hygiene Law, in Article X Health- General of the Annotated Code of Maryland, the Core Service Agency must incorporate in its method of governance a mechanism for the local county mental health advisory committee to serve as the advisory committee to the core service agency; and

WHEREAS, the Cecil County Mental Health Core Service Agency Advisory Board was established to assure the existence and access to mental health services for Cecil County;

WHEREAS, Pursuant to Article 4, Section 412 (b) of the Charter of Cecil County, the County Executive shall appoint all members of boards and commissions, subject to confirmation by the Council; and

WHEREAS, the County Executive has approves the reappointment of Carol Masden and the appointment of Tyra Kenly and Michelle Digiovani to serve on the Cecil County Mental Health Core Service Agency Advisory Board for a 3 year term to expire in March 1, 2018.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the County Council of Cecil County confirms the reappointment of Carol Masden and the appointment of Tyra Kenly and Michelle Digiovani to serve on the Cecil County Mental Health Core Service Agency Advisory Board for a 3 year term to expire in March 1, 2018.
