RESOLUTION NO. 18-2015
Roads - Renaming - Eugene's Way

1 **WHEREAS**, the governing body of a County has control to open, name, alter, or close roads by
2 petition, pursuant to Section 12-512(b) of the Local Government Article of the Annotated Code of
3 Maryland; and

4 **WHEREAS**, the State provides that a resident of the county may request, by petition, that the
5 governing body of a county open, name, alter or close a road; and

6 **WHEREAS**, the County Commissioners of Cecil County, Maryland, adopted a policy for the renaming
7 private maintained roads; and

8 **WHEREAS**, the Department of Planning and Zoning administers this policy by receiving applications
9 to rename a private maintained road, which must include a petition signed by a majority of the landowners
10 that have property which accesses on the subject road, and nonrefundable application fee; and

11 **WHEREAS**, requests for road name changes must be introduced for approval before for the County
12 Council of Cecil County at a public hearing; and

13 **WHEREAS**, the proposed name of the road shall not be a duplicate of or analogous to a road name
14 already in use in Cecil County; and

15 **WHEREAS**, in the case of private roads, the fee simple owner or owners, if determinable, of the road
16 shall sign the application for renaming of the road; and

17 **WHEREAS**, Zachary and Ashley Baeder have submitted an application to change an unnamed road
18 off of Willard Drive, North East, Maryland, which includes the current addresses of 256, 256A, 256B and
19 258 Willard Drive, North East, Maryland, in order to eliminate confusion and potential crisis if emergency
20 services cannot locate these residents; and

21 **WHEREAS**, Zachary and Ashley Baeder have submitted a petition to name the private road
22 "Eugene's Way", and have collected three of the four residents of this road who support this naming; and

23 **WHEREAS**, the Department of Emergency Services has indicated no objection to this road name
24 change.

25 **NOW, THEREFORE, BE IT HEREBY RESOLVED** that the County Council of Cecil County hereby
26 approves the petition that the unnamed road, off of Willard Drive, North East, be named "Eugene's Way",


28 **AND, BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by the
