1 **WHEREAS**, a Local Development Council shall be established in each geographic area where a
2 video lottery facility is located, pursuant to Maryland Annotated Code, State Government Article, Section
3 9-1A-31 and

4 **WHEREAS**, a Local Development Council shall consist of fifteen members appointed by the chief
5 executive of the county in which the local development council is located; and

6 **WHEREAS**, a county shall develop a multiyear plan for the expenditure of the local impact grant
7 funds for services and improvements, in consultation with the Local Development Council; and

8 **WHEREAS**, the Local Development Council will review and comment on the multiyear plan before
9 adopting the plan or expending any grant funds; and

10 **WHEREAS**, the Local Development Council will advise the county on the impact of the facility on
11 the communities and the needs and priorities of the communities in immediate proximity to the facility;
12 and

13 **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County
14 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;
15 and

16 **WHEREAS**, the County Executive has appointed Gary Tennis to serve on the Local Development
17 Council to fill the vacancy left by the resignation of George Patchell.

18 **NOW, THEREFORE, BE IT HEREBY RESOLVED** that the County Council of Cecil County confirms the
19 appointment by the County Executive of Gary Tennis to serve on the Local Development Council to fill the
20 vacancy of George Patchell, with said term to expire on April 21, 2019.

21 **AND BE IT FURTHER RESOLVED** by the County Council of Cecil County that all provisions of this
22 Resolution shall take effect on the date that the Resolution is adopted by the Council.
