**PUBLIC HEARINGS** 

Notice of time and place of public hearing and title of this Resolution having been posted on April 7, 2015 at the County Administration Building, 200 Chesapeake Blvd., Elkton, Maryland, and having been published on April 29, 2015 and May 6, 2015. A public hearing was held on May 12, 2015 and concluded on May 12, 2015.

WHEREAS, pursuant to Section 402 of the Cecil County Charter (the "Charter"), the County Executive (the "Executive") shall see that the affairs of the executive branch are administered properly and efficiently, and that employees of the executive branch faithfully perform their duties; and

WHEREAS, pursuant to Section 402 of the Charter, the duties and responsibilities of the Executive include, but are not limited to: (a) Supervising and directing offices, agencies and divisions of the executive branch and ensuring that County employees as well as County boards and commissions faithfully perform their duties; and, (b) preparing and submitting to the Council the annual County Budget; and

WHEREAS, pursuant to Md. Code Ann., § 5-404, Agriculture Article, the Agriculture Secretary for the State of Maryland (the "Secretary") may receive from any county, municipality, or special taxing district in the State funds for the purpose authorized by this section; and

WHEREAS, pursuant to Md. Code Ann., § 5-404, Agriculture Article, the Secretary may contract with the County with respect to the construction or maintenance of the facilities and other work authorized by this subtitle to control or eliminate mosquitoes in or adjacent to the County; and

WHEREAS, pursuant to Md. Code Ann., § 5-404, Agriculture Article, the County shall carry out the provisions of any contract entered into with the Secretary with respect to the work authorized by this subtitle; and

WHEREAS, Md. Code Ann., § 5-404, Agriculture Article provides that, in order to meet its financial commitments under the contract, the County shall appropriate and, if necessary, levy taxes for these funds and pay them over, as the contract requires; and

WHEREAS, pursuant to Section 408 of the Charter (Tax Levy and Balanced Budget), after enacting the Annual Budget and Appropriations Ordinance, the Council shall levy the amount of taxes required by the Budget to ensure that the Budget is balanced so that proposed revenues equal proposed expenditures; and

WHEREAS, the County Executive has submitted this resolution to set the fee for mosquito spraying in order for the County to meet its financial obligation pursuant to its contract with the Secretary.

NOW, THEREFORE, BE IT HEREBY ENACTED by the County Council of Cecil County, that in accordance with Md. Code Ann., § 5-404, Agriculture Article and Section 408 of the Charter, the fee for mosquito spraying is One Hundred Twenty Dollars (\$120.00) per treatment.
