WHEREAS, pursuant to Section 402 of the Cecil County Charter (the "Charter"), the County Executive (the "Executive") shall see that the affairs of the executive branch are administered properly and efficiently, and that employees of the executive branch faithfully perform their duties; and

WHEREAS, pursuant to Section 402 of the Charter, the duties and responsibilities of the Executive include, but are not limited to: (a) Supervising and directing offices, agencies and divisions of the executive branch and ensuring that County employees as well as County boards and commissions faithfully perform their duties; and, (b) preparing and submitting to the Council the annual County Budget; and

WHEREAS, pursuant to Part II, Chapter 295, Article 2, (Road standard specifications), § 295-5 (Adoption of regulations by reference), of the Cecil County Code, in accordance with the powers and authority vested in the County Executive and County Council of Cecil County, Maryland, a charter county pursuant to Article XI-A of the Maryland Constitution, the Annotated Code of Maryland, and the Cecil County Charter, the County has adopted regulations (as amended from time to time) known as the "Cecil County Road Code and Standard Specifications" for roads in Cecil County; and

WHEREAS, Appendix A (Rules and regulations for utility construction permits), §7.01 (Permit fees and expenses), of the Cecil County, Maryland Road Code provides that a permit fee, established by the County Council, shall be paid for each utility permit; and

WHEREAS, pursuant to Appendix A (Rules and regulations for utility construction permits), §7.01 (Permit fees and expenses), of the Cecil County, Maryland Road Code, the County Council (formerly, the Board of County Commissioners for Cecil County) have established a permit fee for a road utility permit of Fifty Dollars (\$50.00); and

WHEREAS, the County Executive has submitted this resolution to establish a permit fee for a road utility permit of One Hundred Dollars (\$100.00) per permit.

NOW, THEREFORE, BE IT HEREBY ENACTED by the County Council of Cecil County, that in accordance with Part II, Chapter 295, Article 2, (Road standard specifications), § 295-5 (Adoption of regulations by reference), of the Cecil County Code and Appendix A (Rules and regulations for utility construction permits), §7.01 (Permit fees and expenses), of the Cecil County, Maryland Road Code, the permit fee for a road utility permit is One Hundred Dollars (\$100.00).
