Title of Resolution: Budget Amendment - Grant Funds - Sheriff's Office - Medication Assisted Treatment/Reentry -Vivitrol

Synopsis: A resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2016 in order to provide a total of \$47,500 in additions to the General Fund Grants Budget awarded to the Cecil County Sheriff's Office.

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2015, the County
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2016; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2016; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 2, 2015, the
6 County Council adopted the budget for Fiscal Year 2016; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2016 General Fund Budget Cecil County
8 to establish the following amount within the General Fund as follows:

- 9 a) The addition of \$47,500 in grant revenue and expense within the Sheriff’s Office from the
- 10 Governor’s Office of Crime Control and Prevention to administer a Medication Assisted
- 11 Treatment/Reentry (Vivitrol) program within the Cecil County Detention Center. The grant
- 12 provides funding for a Care Coordinator to be hired by the Cecil County Health Department,
- 13 emergency bracelets to identify individuals that have been administered the drug, and
- 14 computer equipment to help with the administrative requirements of the grant program.

15 **WHEREAS**, such appropriation is necessary to provide \$47,500 of grant funding for the General Fund
16 for grant related expenses within the Sheriff’s Office.

17 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
18 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
19 Year 2016 is hereby amended for the supplemental appropriation and by amending the Current Budget to
20 appropriate additional revenue and expenditures in the General Fund grant budget in the amount of
21 \$47,500 within the Sheriff’s Office budget.

22 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that this
23 Resolution shall take effect on the date of its passage.
