Synopsis: A resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2016 in order to provide a total of \$125,000 in additions to the General Fund Grants Budget awarded to the Health Department for the Drug Free Communities Coalition.

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2015, the County
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2016; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2016; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 2, 2015, the
6 County Council adopted the budget for Fiscal Year 2016; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2016 General Fund Budget Cecil County
8 to establish the following amounts within the General Fund as follows:

- 9 a) The addition of \$125,000 in grant revenue and expense from the U. S. Department of Health
10 and Human Services to the Cecil County Health Department budget to fund the Cecil County
11 Drug Free Communities Coalition in Cecil County. This grant is the second year of a five year
12 grant that was awarded in FY2015; however the budget was omitted from the FY2016
13 Approved Budget.

14 **WHEREAS**, such appropriation is necessary to provide \$125,000 of grant funding for the General Fund
15 for grant related expenses within the Cecil County Health Department; and

16 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
17 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
18 Year 2016 is hereby amended for the supplemental appropriation and by amending the Current Budget to
19 appropriate additional revenue and expenditures in the General Fund grant budget in the amount of
20 \$125,000 within the Cecil County Health Department.

21 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that this
22 Resolution shall take effect on the date of its passage.
