RESOLUTION NO. 41-2015
Appointment - Local Development Council

1 **WHEREAS**, a Local Development Council shall be established in each geographic area where a video
2 lottery facility is located, pursuant to Maryland Annotated Code, State Government Article, Section 9-1A-
3 31; and

4 **WHEREAS**, a Local Development Council shall consist of fifteen members appointed by the chief
5 executive of the county in which the local development council is located; and

6 **WHEREAS**, a county shall develop a multiyear plan for the expenditure of the local impact grant
7 funds for services and improvements, in consultation with the Local Development Council; and

8 **WHEREAS**, the Local Development Council will review and comment on the multiyear plan before
9 adopting the plan or expending any grant funds; and

10 **WHEREAS**, the Local Development Council will advise the county on the impact of the facility on the
11 communities and the needs and priorities of the communities in immediate proximity to the facility; and

12 **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County
13 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;
14 and

15 **WHEREAS**, the County Executive has appointed S. Joseph Moore to serve on the Local Development
16 Council, term to expire July 31, 2019.

17 **NOW, THEREFORE, BE IT HEREBY RESOLVED** that the County Council of Cecil County confirms the
18 appointment by the County Executive of S. Joseph Moore to serve on the Local Development Council who
19 will be assuming the seat of outgoing member, Dale DeWeese, term to expire July 31, 2019.

20 **AND BE IT FURTHER RESOLVED** by the County Council of Cecil County that all provisions of this
21 Resolution shall take effect on the date that the Resolution is adopted by the Council.
