Supplemental Appropriation - Grant - Economic Development - US Department of Agriculture

**WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2015, the County Executive submitted a proposed budget to the County Council for Fiscal Year 2016; and

**WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2016; and

**WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 2, 2015, the County Council adopted the budget for Fiscal Year 2016; and

**WHEREAS**, the County Executive is revising the Fiscal Year 2016 General Fund Grants Budget for Cecil County to establish the following amounts as follows:

- a) The addition of \$21,400 in grant revenue and expense within the Office of Economic Development from the United States Department of Agriculture to provide funding for the Bassmaster Elite Tournament and Summerfest to be held in August 2015.

**WHEREAS**, such appropriation is necessary to provide \$21,400 of grant funding for the General Fund Grants Budget for grant related expenses within the Office of Economic Development; and

**NOW THEREFORE, BE IT HEREBY RESOLVED** that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal Year 2016 is hereby amended for the supplemental appropriation and by amending the Current Budget to appropriate additional revenue and expenditures in the General Fund Grants Budget in the amount of \$21,400 within the Office of Economic Development.

**AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by the County Council of Cecil County, Maryland.
