Supplemental Appropriation - Grant - Human Services Agency - Children in Need of Supervision

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2015, the County
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2016; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2016; and,

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 2, 2015, the
6 County Council adopted the budget for Fiscal Year 2016; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2016 Community Services Fund Grant
8 Budget revenue estimate for Cecil County to establish the following amount within the Community Services
9 Fund as follows:

- 10 a) The addition of \$50,000 in grant revenue and expense to the Cecil County Human Services
11 Agency's budget to fund the Children in Need of Supervision Program (CINS) in Cecil County
12 awarded by the Maryland Department of Juvenile Services.

13 **WHEREAS**, such appropriation is necessary to provide \$50,000 of grant funding for the Community
14 Services Fund for grant related expenses within the Cecil County ; and

15 **NOW THEREFORE, BE IT HEREBY RESOLVED** that the Annual Budget and Appropriation Ordinance for
16 Cecil County, Maryland for Fiscal Year 2016 is hereby amended for the supplemental appropriation and by
17 amending the Current Budget to appropriate additional revenue and expenditures in the Community
18 Services Fund grant budget in the amount of \$50,000 within the Cecil County Human Services Agency.

19 **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by the
20 County Council of Cecil County, Maryland.
