COUNTY COUNCIL OF CECIL COUNTY WORK SESSION MINUTES March 04, 2014

Approval of Minutes

On a motion made by Councilwoman Broomell, seconded by Councilman Dunn, the Council moved to postpone approval of the Work Session meeting minutes for February 25, 2014.

Council President Hodge reminded the Council what the contents of meeting minutes are to include, according to Robert's Rules of Order.

The motion passes 3-2, with Councilwoman Bowlsbey and Council Vice President McCarthy opposed.

Discussion – Letter of Support-Vote Tally

Council discussed on whether a vote tally should be included with a letter of support. Discussion and comments ensued.

On motion made by Vice President McCarthy, seconded by Councilwoman Bowlsbey, the Council moved to present the letters of support on a case by case basis stating what the Council wants to do and the majority rules; the names will not be included.

Councilwoman Broomell made a motion to amend the previous motion to include the vote if the committee requests it.

The motion was seconded by Councilman Dunn, but failed by a vote of 2-3.

The original motion by Vice President McCarthy passed by 3-2.

Discussion and comments ensued.

On motion made by Vice President McCarthy, seconded by Councilwoman Bowlsbey the Council moved to change the time of the March 11 budget hearing from 1:30 p.m. to 12:00 p.m. Discussion and comments ensued.

The motion carries 5-0.

Location of Council meetings during Early Voting

The Council discussed changing the location of the Council meetings during early voting from the Elk Room to the Elkton Town Hall.

Discussion and comments ensued.

On motion made by Councilwoman Bowlsbey, seconded by Councilwoman Broomell the Council moved to change the location of the Council meetings during early voting to the Elkton Town Hall. Discussion and comments ensued.

The motion failed 4-1, with Councilwoman Bowlsbey, Councilman Dunn, Vice President McCarthy and President Hodge opposed.

On motion made by Vice President McCarthy, seconded by Councilwoman Bowlsbey the Council moved to conduct the Council meetings in the Senior Center, provided it does not impact the seniors. Discussion ensued. The motion failed 3-2, with Councilwoman Broomell, Councilman Dunn, and President Hodge opposed.

Council Manager Massey was asked to determine if there was adequate microphones and audio recording at the Senior Center.

Requests for Presentations

The Council discussed requests for presentations related to Councilwoman Broomell request to meet with Executive Director Bruce Gartner from the Maryland Transportation Authority. The Council President has the approval of the agenda and must approve requests for presentations.
