President Hodge requested Council Manager James Massey to provide an amendment for the Legislative meeting regarding the Sick Leave Buy Back Policy.

Discussion with the Council and staff continued regarding the FY2014 Budget.

On motion made by Vice President McCarthy, seconded by Councilwoman Bowlsbey, the Council moved to amend Amendment #4 to Resolution 17-2013 to change the interest rate from 6% to the prime plus 2% interest rate. Motion carried unanimously.

On motion made by President Hodge, seconded by Councilwoman Bowlsbey, the Council moved to approve Amendment #4 as amended, that provides financing of the Major Facility Fee by permitting the applicant to pay one-third when initially billed, and then one-tenth of the balance annually with property taxes at an interest rate of prime plus 2 %.
