# COUNTY COUNCIL OF CECIL COUNTY LEGISLATIVE SESSION MINUTES LSD 2015-08 April 21, 2015

#### **CALL TO ORDER**

The meeting of the County Council of Cecil County of April 21, 2015 was called to order by President Hodge at 7:00 p.m. and opened with the Pledge of Allegiance.

Councilman Schneckenburger introduced Rev. Laurie Loveless from Elkton Presbyterian Church to deliver the opening prayer.

#### APPROVAL OF AGENDA

# Bill No. 2015-04 Amendment - Zoning Code - Floodplain District

An Act to amend the Zoning Code Ordinance, Article XI, Part III Floodplain District; and includes changes in definition of historic structure, size of accessory structure in certain zones, application variances for historic structures; and updates version of Flood Insurance Study used.

Bill No. 2015-03 Budget Amendment - Capital Budget - Board of Education

A Bill to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2015 to transfer existing bond appropriation authority within the Board of Education Capital Projects Budget in the amount of \$193,139.60 from other School Capital Projects to the New School of Technology Renovations Project.

The Bill was introduced on March 3, 2015 and public hearing held on April 7, 2015.

Applicant: Anthony E. and Sharon K. Nonn; Property Location: 2125 Barksdale Road, Elkton, MD 21921; Election District:4; Tax Map: 14 and 21; Parcel: 47, 109 and 600; Presently zoned: LDR; Request: ST; Property Owner: Anthony E. and Sharon K. Nonn

On motion made by Councilwoman Bowlsbey, seconded by Vice President McCarthy, the Council moved to approve the application of Anthony E. and Sharon K. Nonn to rezone 38.10 acres located at 2125 Barksdale Road, Elkton, MD from LDR (low density residential) to ST (suburban transition) based upon a mistake in the zoning classification of the property during the last comprehensive rezoning.
