Board of County Commissioners Worksession Minutes May 8, 2012

Closed Session Meeting – May 1, 2012

The Board convened in closed session on May 1, 2012 at 10:40 a.m. Motion was made by Commissioner Moore, seconded by Commissioner Dunn, pursuant to the Maryland Annotated Code State Government 10-508 (a) (i) 1 - Personnel matters to discuss pending appointment to the Tax Appeal Board and appointments to the Planning Commission, Board of Appeals and Board of License Commissioners; and 2 - personnel matters relating to EMS matters. Motion carried unanimously.

The Board discussed the ambulance service proposal and appointments to the EMS Advisory Board. The consensus of the Board was to direct County Administrator Wein to schedule a closed session meeting on May 8, 2012 with EMS Director Richard Brooks relating to EMS matters.

Request to Fill Positions

Director Nichols advised the Board that the following departments have submitted a request to fill the following budgeted positions:

Crew Leader in Roads Division:

Civil Engineer III in DPW Engineering and Construction Division;

Operator I in Water/Wastewater Division; and

Volunteer Development Associate in Senior Services and Community Transit

The Board concurred to authorize the Human Resources Department to advertise and fill the positions as presented.

Proposed zoning text amendment relating to nonconforming situations

Director Sennstrom reviewed the proposed zoning text amendment to Article XVIIII Nonconforming Situations, Section 329 Intent and Section 334 Abandonment and Discontinuance of Nonconforming Situation.

Members of the Board provided their comments regarding the proposed zoning text amendments.

Commissioner Hodge commented that he would prefer more clarification of the language in the ordinance and would provide a draft to the Board.

Lower Susquehanna Heritage Greenway (LSHG) Capital Projects Review

Mary Ann Lisanti, Executive Director of the LSHG, reviewed the proposed capital projects for the organization. The organization has preserved over 200 acres of land through partnerships with private, federal, state and local agencies for the development of passive recreation. The designation of a "National Trail" significantly changes the opportunities and direction for the project.

Members of the Board provided their comments regarding the capital projects for LSHG.

Chesapeake City/Bohemia Manor School complex wastewater options

Director Flanigan provided the Board the results of an internal analysis of the water and wastewater issues at the Chesapeake City/Bohemian Manor School complex. He outlined four options and the proposed cost to implement each.

Discussion ensued regarding:

- . Potential benefits to other parties along the water and sewer line;
- . Investment for county, town and school;

- . Proposed timeline for the project;
- . Priority funding area;
- . Risk of penalties for the town and school system if they do not meet the October 31, 2013 deadline for compliance with the standards;
- . County Water and Wastewater Plan;
- . Project costs and proposed county contribution; and
- . Potential funding from commitments on connection fees

The consensus of the Board was to direct County Administrator Wein to contact Chesapeake City Mayor Frank Hill regarding the draft Memorandum of Understanding.
