### **OPEN SESSION**

9:00 a.m. – Vice President Broomell called the meeting to order.

**Easement Acquisition Proposal -** Bill Kilby from Cecil Land Trust provided the Board an overview of the easement acquisition proposal for the Carson property.

Discussion ensued regarding:

- the funding for the county portion of the acquisition; and
- . property appraisal and land value

Mr. Kilby advised the Board that he would provide a copy of the appraisal. The Board concurred to postpone a decision on the easement until the November 15, 2011 Commissioners meeting.

Mr. Kilby reviewed an additional easement submitted for the McCoy farm relative to an installment purchase plan option.

The Board concurred to authorize the Cecil Land Trust to proceed with negotiations relative to the McCoy farm easement subject to funding.

**Economic Development Director Recruitment Process Update** – Director Nichols provided the Board an update to the recruitment process for the economic development director position.

**Requests to Fill Positions** - Director Nichols advised the Board that a request to fill was submitted for a budgeted Social Worker I in Social Services and part-time bus driver in Senior Services and Community Transit.

The Board concurred to authorize the Human Resources department to proceed with advertising and filing the positions as presented.

Director Nichols provided the Board an overview of the "penny war" for the United Way campaign.

**Draft RFP 12-17; Design and Installation of New Metal Roof and Metal Siding to Central Facility Salt Barn** – Public Works Director Flanigan provided the Board an overview of draft RFP 12-17.

The Board concurred to authorize the Public Works department to proceed with advertising Draft RFP 12-17 for the design and installation of a new metal roof and metal siding to the central facility salt barn.

**Economic Development Business Incentives** – Acting Economic Development Director Clough provided the Board an overview of business incentives in Cecil County.

Board members provided their comments relative to business incentives. The Board concurred to schedule an afternoon discussion session on county initiatives to attract new business and support business expansion and to proceed with scheduling a local business summit.
