The meeting of the Board of County Commissioners for Cecil County, May 10, 2011 was called to order by Commissioner Mullin at 2:00 p.m. and opened with the Pledge of Allegiance.

President Mullin, opened the meeting with a brief over view of the FY12 Proposed Budget. The proposed tax rate is \$.9451 of \$100 of assessed value, which is higher than FY11 tax rate of \$.9153, which reflects the impact of the decline in assessments. For a second year in a row the Cecil County Board of County Commissioners has adopted a tax rate equal to the constant yield rate.
