Health Report

Health Officer Garrity presented the annual summary of the 2012 bathing beach sampling program, the Rabies vaccination clinic statistics from calendar year 2007-2012 and an update on the 2012 Flu Season.

She advised the Board that on November 13, 2012 the Health Department will be conducting a flu vaccination clinic, based on income and insurance. The cost associated for the flu shot is \$18.00 and \$24.00 for the flu mist. She also advised that flu mist would be available to all Elementary School students.
