1           **WHEREAS**, pursuant to Section 191-10(I) of the Code of Cecil County, the Board of Electrical  
2 Examiners shall review applications and recommend to the County approved electrical inspection agencies,  
3 and

4           **WHEREAS**, pursuant to Section 191-18 of the Code of Cecil County, the County shall appoint such  
5 inspectors and license such inspection agencies as defined in the Code as the County so desires to protect  
6 the health, safety and welfare of the citizens of Cecil County, and

7           **WHEREAS**, pursuant to Section 191-18(A), one or more nongovernmental organizations may be  
8 designated from time to time as an approved inspection agency or agencies; and

9           **WHEREAS**, Bay Area Inspection Agency and American Inspection Agency, Inc. currently conduct the  
10 electrical inspections in Cecil County; and

11           **WHEREAS**, the Board of Electrical Examiners has reviewed the qualifications of Bay Area Inspection  
12 Agency and American Inspection Agency, Inc. for consideration for re-appointment as an electrical  
13 inspection agency for Cecil County; and

14           **WHEREAS**, the Board of Electrical Contractors recommends that Bay Area Inspection Agency and  
15 American Inspection Agency, Inc. be considered for reappointment as an electrical inspection agency for  
16 Cecil County.

17           **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**  
18 **MARYLAND** confirms the re-appointment of Bay Area Inspection Agency and American Inspection Agency,  
19 Inc. as electrical inspection agencies for Cecil County for the term beginning July 1, 2016 to July 31, 2017.

20           **AND, BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by  
21 the County Council of Cecil County, Maryland.
