2	Maryland, Section 3-501, each local Department of Social Services shall have a local board consisting of at
3	least nine (9), but no more than thirteen (13) members who have a high degree of interest, capacity, and
4	objectivity; and in the aggregate, give a countywide representative character to the local board, and
5	WHEREAS, Title 3, Subtitle 5, Section 3-503 of the Annotated Code of Maryland defines the duties
6	and functions of a local Social Services Board as an advisory board to the local director for the local
7	application and implementation of State policies or procedures, which includes evaluating and making
8	recommendations to improve current services and develop new services as needed in the county; and
9	serving as the liaison with the local government authority and residents to communicate the objectives,
10	policies and programs of local social services and public assistance administration; and
11	WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County
12	Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;
13	and
14	WHEREAS, the County Executive has reappointed Dianne Fox and Judith Cox to serve on the
15	Department of Social Services Board; and
16	NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,
17	MARYLAND confirms the reappointment by the County Executive of Diane Fox and Judith Cox to serve on
18	the Department of Social Services Board to for a three year term to expire on June 30, 2019; and
19	AND BE IT FURTHER RESOLVED that this Resolution shall take effect on the date of its passage by
20	the County Council of Cecil County, Maryland.
