1 **WHEREAS**, a local jurisdiction may establish by local law a planning commission with the powers and
2 duties, pursuant to Section 2-101 in the Land Use Article of the Annotated Code of Maryland; and

3 **WHEREAS**, the Cecil County Board of Appeals shall consist of five regular members and one alternate
4 member, who must be residents of Cecil County; pursuant to Section 9-704 in the Land Use Article of the
5 Annotated Code of Maryland; and

6 **WHEREAS**, the Cecil County Board of Appeals shall be appointed by the County Executive and
7 approved by the County Council, pursuant to Section 298, Article XVI of the Cecil County Zoning Ordinance;
8 and

9 **WHEREAS**, the power and duties of the Board of Appeals are to hear and decide appeals when it is
10 alleged that there is an error in any order, requirement, decision, or determination made by the Zoning
11 Administrator or any other administrative official in the enforcement of the zoning ordinance; and to hear and
12 decide special exceptions as provided in the zoning ordinance; and to authorize upon application a variance
13 from the provisions of the zoning ordinance; and

14 **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County Executive
15 shall appoint all members of boards and commissions, subject to confirmation by the Council;

16 **WHEREAS**, The County Executive approves the appointment of Willard Whiteman, who will be
17 replacing Cecil Shannon Whitley, to the Board of Appeals for a three year term to expire on August 15, 2019.

18 **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**
19 **MARYLAND** confirms the appointment of Willard Whiteman to the Board of Appeals for a three year term to
20 expire August 15, 2019.

21 **AND, BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by the
22 County Council of Cecil County, Maryland.
