WHEREAS, the Workforce Innovation and Opportunity Act, WIOA, Public Law 113-128, was
adopted by Congress to reform and strengthen the workforce investment system of the Nation, to put
Americans back to work, and make the United States more competitive in the twenty-first century; and
WHEREAS, the Workforce Innovation and Opportunity Act, Section 207 of HR 803, establishes local
workforce development board in each local area of a State to carry out the functions of this program; and
WHEREAS, the local workforce development board is composed of a majority of business
representatives in the local area, while not less than twenty per cent of the members shall be
representatives of the workforce, education and training, government economic development and
elected officials; and
WHEREAS, the local board, in partnership with the chief elected officials for the local area, shall
develop and submit a local comprehensive plan to the Governor to provide programs that will improve
employment and economic conditions within the locality; and
WHEREAS, Cecil County and Harford County have been designated as the Susquehanna Regional
Workforce Area by the Governor of Maryland; and
WHEREAS, the Susquehanna Workforce Network, Inc. shall be governed by a Workforce Board and
consist of a minimum of 51% membership who represent the private sector; and
WHEREAS, members of the Workforce Board from Cecil County shall be appointed by the County
Executive of Cecil County, subject to the confirmation of the County Council of Cecil County; and
WHEREAS, the Workforce Board will provide policy guidance and oversight for the workforce
development initiatives in the Susquehanna region.
WHEREAS, the Workforce Board will be responsible for developing a strategy to continuously
improve and strengthen the workforce development system through innovation in, and alignment and
improvement of, employment, training, and education programs to promote economic growth; and
WHEREAS, the County Executive approves the reappointment of Dr. D'Ette Devine, Terrance Lovell
and Dan Schneckenburger to the Susquehanna Workforce Network Board.
NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,

MARYLAND, confirms the reappointment of Dr. D'Ette Devine, Terrance Lovell and Dan Schneckenburger

to the Susquehanna Workforce Network Board to a three year term, which will expire on June 30, 2019.
