the Commission shall be affiliated with the same polit	cical party;
WHEREAS, the Ethics Commission is currently	comprised of two members who are affiliated with
the Republican Party, one member who is affiliated w	rith the Democratic party, and one member who is
unaffiliated; and	
WHEREAS, pursuant to Section 412(b) of the 0	Charter of Cecil County, the Executive shall appoint all
members of boards and commissions and that such m	nembership shall be subject to confirmation by the
Council;	
WHEREAS, the County Executive approves the	e appointment of L. Michelle Henson, who is registered
Democrat, for a four year term to expire April 5, 2020	).
NOW, THEREFORE, BE IT HEREBY RESOLVED	that the County Council of Cecil County confirms the
appointment of L. Michelle Henson to the Cecil Cou	nty Ethics Commission for a four year term to expire
April 5, 2020; and
